## A Note About Medicare Replacement Plans

There are a number of Medicare replacement plans that are offered in our service area. These plans are also known as *Medicare Advantage Plans*. If a person chooses one of these plans, it completely replaces their Traditional Medicare coverage and is offered through an Insurance Company. A Medicare Advantage Replacement Plan might be a PPO Plan, a Private-Fee-For-Service Plan (PFFS), or an HMO Plan. The Medicare Replacement plans with which our hospitals are contracted and in-network are listed below. There are many other Medicare Advantage Plans being sold in our service area. Baptist Health Care's hospitals accept many of these other plans and are happy to take care of their policy holders' needs. However, the members' out of network benefits might apply. Be sure to verify, with the Insurance Company, whether your in-network or out-of-network benefit will be applied. ### **Limited Benefit Plans**

Most limited benefit plans do not provide coverage for all services. Review your policy closely to determine if it covers Hospital and Emergency Services and if there are annual limits. The insurance you purchase could be limited to physician office visits and preventative care or may just be catastrophic in nature. Once the limited benefits have been exhausted, other sources of funding the care delivered will be explored.
